SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The Offer Price has been determined at HK\$0.60 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.60 per Offer Share and 130,000,000 Shares offered by the Company, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commission and estimated expenses paid and payable by the Company in relation with the Share Offer, are estimated to be approximately HK\$53.0 million (equivalent to approximately S\$9.1 million). The Company intends to apply such net proceeds in the manner set out in the paragraph headed “Net proceeds from the Share Offer” below in this announcement and the section headed “Future Plans and Use of Proceeds” of the Prospectus.

The Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 20,757 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 1,959,000,000 Public Offer Shares, equivalent to approximately 150.69 times of the total number of 13,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the aforesaid level of over-subscription in the Public Offer, the re-allocation mechanism as described in the paragraph headed “Structure and Conditions of the Share Offer — Re-allocation of the Offer Shares between Placing and Public Offer” of the Prospectus has been applied. As the number of Offer Shares validly applied for under the Public Offer represents 150.69 times of the Offer Shares initially available for subscription under the Public Offer, 52,000,000 Shares have been re-allocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 65,000,000 Offer Shares, representing 50% of the total number of Offer Shares initially available under the Share Offer.

The Placing

- The Placing Shares initially offered under the Placing have been slightly over-subscribed, which is equivalent to approximately 1.04 times of the total number of 117,000,000 Offer Shares initially available under the Placing. The final number of the Placing Shares under the Placing is 65,000,000 Placing Shares, representing 50% of the total number of the Offer Shares available under the Share Offer. A total of 32 places have been allotted ten board lots of Offer Shares or less, representing approximately 17.9% of the total number of places under the Placing. A total of 1,285,000 Placing Shares have been allotted to these places, representing approximately 2.0% of the Placing Shares.

The Company currently intends to apply such net proceeds as follows:

- approximately S\$2.6 million, representing approximately 28.5% of the net proceeds, will be used to strategically expand and strengthen the network of the Group's DTAP Clinics;

Two applications have been rejected due to dishonoured cheque. 65 multiple or suspected multiple applications have been identified and rejected. One invalid application has been identified. No application for more than 100% of the Public Offer Shares initially available under the Public Offer (that is, more than 13,000,000 Public Offer Shares) has been identified.
